Dear Parents and Guardians,

Welcome back to Term 4, our last term of the year and one that is always full of lots of events, learning and decisions. I hope you enjoyed the time available over the holidays with your children. I know it is a great opportunity for everyone, students and teachers, to recharge their batteries and come back to school ready for great learning in term 4.

**Classes for 2019:** We are about to begin the process of forming new class grouping for 2019. Over the next few weeks each teacher will ask their students to choose 3-4 children they think they work well with. The process will ensure that each child gets at least one person of their choices. In addition, if you have any concerns or requests about whom your child should or shouldn't be with please put these in writing before **Friday 26th October**. Any requests received after this date <u>WILL NOT</u> be able to be considered, due to the flow-on effect that any changes to classes already made has across the board. I will need to stick to this timeline quite tightly to ensure the process runs as smoothly and as efficiently as possible. Please note, requests for specific teachers will not be considered. If you have any questions or concerns in regards to this process, please do not hesitate to contact the office to make an appointment to speak with me. If you know your child will not be attending Melton West Primary School in 2019, please let us know by completing the attached slip so that we can ensure that any of your child's friends are not disadvantaged if your child is their only friend allocated to their new class. If you are unsure at this stage, please put in the note and write "POSSIBLY". This will not mean you cannot come to Melton West PS next year, it will just give us an indication of what is possible.

**Assembly Term 4**: Due to the warm weather fast approaching in term 4 each year, we change the starting time of our Friday Assemblies to 9.00am, before the sun gets too warm. Please come along and join us for this important weekly celebration of students and their achievements.

**No Hat No Play:** We have a Sun Smart policy which outlines when hats need to be worn outside during recess and lunch and during sport events and sessions held outside. I have attached a copy with this newsletter for your information. Please ensure your child has a school approved royal blue, broad-brimmed hat, available at Lowes at Woodgrove Shopping Centre before Monday or they will be directed under a shady area by the yard duty teachers, for their protection. During Term 1 we had many children disregard the direction of the teacher to move to a shady area if they were not wearing the correct hat. This year we will make contact with the parent if your child refuses to do as directed and would appreciate if you could have a conversation about the importance of being sun safe to support us and your child by ensuring they have an appropriate hat. Please ensure they have their name clearly marked on the hat. If a child continues to refuse after contact with a parent has been made, they may need to spend their lunch break supervised inside.

**2019 Prep Enrolments:** I have been conducting school tours for parents who have children due to start school next year in Prep. We have begun taking enrolments and encourage you to complete a form if you have a pre-schooler or encourage your friends to book a tour if their first child is starting school. Please be aware there are boundaries in place that designate our catchment area for new families. Please ask your friend to check at the office if they are unsure as to whether they fit within our area.

Language Other Than English (LOTE) Review/FEEDBACK: In term 3 we introduced the teaching of the Chinese Language (Mandarin) as our LOTE subject. This is conducted via the internet with the teachers calling in from Beijing via the computer for each session. We are currently seeking feedback from the teachers and students about the effectiveness and engagement of this approach so we can make a decision about this for next year. If your child has made a comment to you about learning Chinese in this format, either positive or negative, we would be most interested in hearing about it. You can do this by writing a note or sending an email to melton.west.ps@edumail.vic.gov.au. Looking forward to hearing your thoughts.

**No Bell Trial** <u>FEEDBACK</u>: Last term we trialled having no bells, just music to indicate for children to enter the classes at the start of the day and after recess and lunch. We are seeking feedback from children and teachers about this, whether they like it or not and what they see are the pros and cons to having no bells. I am also interested to hear form parents having no bells. I will take any I receive before 4.00 pm on Monday to School Council for discussion and consideration. Looking forward to hearing from you about this matter.

### 1. PURPOSE

- Over exposure to the sun presents a serious health risk. Students must therefore be educated as to
  the need for suitable sun protection, and protected from over exposure to the sun whilst at school.
  Sun protection is used 'during the daily local sun protection times (whenever UV levels are
  three or above)' and NOT just during terms one and four. The 'SunSmart UV Alert' is now
  just referred to as the *daily sun protection times*. The sun protection times are issued
  whenever UV levels reach three and above. It is important to use a combination of sun
  protection measures during these times and never just rely on one. Sun protection times are
  also available on the free SunSmart app or at sunsmart.com.au or myuv.com.au. If students
  are unable to follow the daily sun protection times, they are encouraged to use sun
  protection from *mid-August to the end of April* when average UV levels are three or higher
  in Victoria.
- To assist with the implementation of this policy, staff and students are encouraged to access the daily local sun protection times via the <u>SunSmart widget</u> on the school's website, the free <u>SunSmart app</u>, or at <u>sunsmart.com.au</u> or <u>myvu.com.au</u>.

## 2. POLICY STATEMENT

Ensure all children, educators and staff have some UV exposure for vitamin D.

Ensure all children, educators and staff are well protected from too much UV exposure by using a
combination of sun protection measures during the daily local sun protection times (issued
whenever UV levels are 3 and above).

- Ensure the outdoor environment is sun safe and provides shade for children, educators and staff.
- Ensure children are encouraged and supported to develop independent sun protection skills.
- Support duty of care and regulatory requirements.

 Support appropriate OHS strategies to minimise UV risk and associated harms for educators, staff and visitors.

## 3. IMPLEMENTATION

- a) The sun protection measures outlined in the policy are used for all outdoor activities during the daily local sun protection times.
- b) This policy is to be read as part of our Student Dress Code.
- c) Children will be required to wear School Council approved school uniform, which will include shirts with collars, longer styled shorts and skirts.
- d) Students and staff are required to wear broad brimmed hats, that protect their face, neck and cars (at least 5-6 cm rigid brim). Peak caps and visors are not considered a suitable alternative.
- Appropriate School Council approved school uniform hats for students will be readily available for purchase through Lowes available at Woodgrove Shopping Centre Melton.
- f) The school supplies SPF30 or higher broad spectrum, water-resistant sunscreen for staff and student use. Strategies are in place to remind students to apply sunscreen before going outdoors (e.g. reminder notices). Sunscreen is applied before going outdoors in Terms 1 and 4.
- g) School Assemblies will be held in the mornings in Terms 1 and 4 to avoid the heat of the later part of the day.
- h) School Council also approves students wearing close fitting UV protection wrap around AS1067 sunglasses whenever they are outside.

- Children without broad brimmed hats or appropriate clothing will be restricted to play in designated shaded areas.
- j) Whenever possible, outside activities will be planned in shaded areas.
- k) Hot Day timetable to be implemented (subject to extreme weather)
- The school council will provide adequate shade structures for students as practicable; particularly over high density play areas such as sand pits and play equipment.
- m) Students are encouraged to use available areas of shade when outside.
- n) The school newsletter and school assemblies will be used to highlight and reinforce the need for sun
  protection and using shaded areas.
- Our school is a member of the SunSmart Schools and Early Childhood Program at Cancer Council Victoria.

## 30 SPF SUNSCREEN AVAILABLE IN CLASSROOMS

Dear Parents and Guardians,

As part of our Sunsmart and Heat Policy, the school has supplied each classroom with a pump bottle of Cancer Council 30 SPF Sunscreen. Teachers will remind children that it is available for use on a regular basis, however children will be expected to apply their own sunscreen if they choose to use the school supplied.

I have included a copy of the brand we are supplying, with the list of ingredients so that you can advise your child/ren whether it is a brand that suits them. Some sunscreens have been known to cause skin reactions, so if you are aware that your child has issues with this particular brand or any of the ingredients you are free to supply your own sunscreen, which they can apply themselves.

Please let your child's teacher know if you DO NOT want your child to have access to the sunscreen supplied by the school.

You may like to put the first application on at home as part of your daily routine, in case they forget to apply the school supplied sunscreen.

PLEASE NOTE: Teachers will not be applying the sunscreen. They will remind the children it is available for their use.

Please chat to your child at home about how to apply sunscreen to the exposed areas of the skin. Yours Sincerely
